
#### **Important product information**

#### Storage and handling

Before usage of the RM, it should be allowed to warm to room temperature. No drying is required, as assigned values are already corrected for the content of water and other volatile materials.






### **Assigned value**

Assay "as is": 99.51 %; U = 0.45 %

The assay "as is" is assessed by quantitative NMR spectroscopy and is equivalent to the assay based on the not-anhydrous and not-dried substance. The assay is verified by 100% method (mass balance).

The verified result lies inside our acceptance criteria, i.e. less than 1.0 % difference to assay assigning technique.

For quantitative applications, use the assay as a calculation value on the "as is basis". The uncertainty of the assay can be used for estimation/calculation of measurement uncertainty.

#### Method 2: Value verifying technique - 100% method 100% method (mass balance) with chromatographic purity by HPLC Result 100.00 %

The calculation of the 100% method follows the formula:

Assay (%) = (100 % - volatile contents (%)) \* 
$$\frac{\text{Purity (\%)}}{100 \%}$$

Volatile contents are considered as absolute contributions and purity is considered as relative contribution. Inorganic residues are excluded by additional tests.



The content of the analyte was determined as ratio of the peak area of the analyte and the cumulative areas of the purities, added up to 100 %. System peaks were ignored in calculation.

#### **Inorganic residues**

Method: Sulphated ash, EP 8.7 (2.4.14)\*

According to the available data, the presence of inorganic impurities in the reference substance other than those detectable by sulphated ash is highly unlikely. Inorganic residues can be excluded by results of the sulphated ash. Therefore, no assay correction was performed for inorganic impurities.








# **Identity** The identity is assessed by ISO/IEC 17025 accredited testing methods. Method Conditions Resuit <sup>1</sup>H-NMR Structure confirmed 400 MHz, DMSO-d<sub>6</sub>
